

CE Activity Application Timelines – Updated!

Please note that CE activity applications should be submitted <u>at least 90 days prior</u> <u>to the start date</u> of the activity. Specific timelines for each activity type are listed below.

- Course applications will not be accepted within 60 days of the start date
- RSS applications **will not be accepted within 45 days** of the start date
- Enduring material applications do not have a timeline for submission

2024 Continuing Education RSS Parent Activity Applications

RSS Activity Applications for 2024 with a start date of 1/1/2024 will need to be submitted no later than **October 3, 2023.** CE applications must be submitted at least 90 days prior to the intended start date to avoid a late fee.

Please **do not use the copy or duplicate option with applications.** Coordinators will need to select **Create New Application** in the application portal.

The 42nd Annual Kalamazoo Community Medical and Health Sciences Research Day will be held April 3-4, 2024 at W.E. Upjohn M.D. Campus in Downtown Kalamazoo, Michigan. This is an opportunity to highlight the breadth of research and scholarly activity accomplished by our scientific community.

The 2024 Research Day will showcase WMed efforts to promote translational research from bench to bed side and will feature highly focused talks on topics that include, but not limited to, basic and translational science, clinical research, public health, medical ethics and law, social and behavioral sciences, and education-related research.

The event will consist of a series of oral presentations, poster sessions, and workshops.
