# Claiming CE Credit

During the conference, you will be able to claim credit for each session you attend using a unique activity code assigned to each session.

For instance, if you attend all six sessions, you'll need to claim credit and complete evaluations for each of these sessions using the designated activity codes provided at the start of each session. We understand that may be a lengthy process, but it serves the purpose of generating customized certificates, featuring all the necessary licensure topics, to simplify your licensure renewal.


You have **12 hours** immediately following the activity to submit activity codes.

Complete the evaluation within **30 days** of the activity date to receive your certificate. Evaluations can be found by signing in to the CE Portal and clicking My CE, then Evaluations & Certificates.


There are two convenient ways to claim credit:

**1. Texting:** You can text (one activity code per text message) to the WMed CE number at 269.743.4779.

**2. CloudCME App:** We strongly encourage you to download the CloudCME App before the conference and enter "wmed" as the organization code. This mobile app streamlines the process of claiming credit, completing evaluations, accessing your certificates, and updating your profile, all in one place.

**My Evaluations** lists any evaluations you need to complete to receive CE credits.







After completing an evaluation, you can find the certificate you were awarded in **My Certificates**, or you can view all of your credits with **My Transcript**.





Use **My Profile** to make changes to your personal info, update your contacts, and specify your specialty as well as the credit types you'll receive for activities.

# To Download

To get the app on your mobile phone, visit the **App Store** on your iPhone, or the **Google Play** store on Android phones, and search for “**CloudCME.**”



Once you have installed the app, open CloudCME. If this is the first time you are using the app, you'll be asked to enter your organization code, which is **wmed.**



On the next screen, you'll be able to login to your account or create a new one if you are using the CE system for the first time.

# Accreditation

In support of improving patient care, Western Michigan University Homer Stryker M.D. School of Medicine is jointly accredited by the Accreditation Council for Continuing Medical Education (ACCME), the Accreditation Council for Pharmacy Education (ACPE), and the American Nurses Credentialing Center (ANCC), to provide continuing education for the healthcare team.

## Interprofessional Continuing Education

This activity was planned by and for the healthcare team, and learners will receive 7.0 Interprofessional Continuing Education (IPCE) credits for learning and change.

## Physicians

Western Michigan University Homer Stryker M.D. School of Medicine designates this live activity for a maximum of 7.0 *AMA PRA Category 1 Credits™*. Physicians should claim only the credit commensurate with the extent of their participation in the activity.

## Nurses

Western Michigan University Homer Stryker M.D. School of Medicine designates this activity for 7.0 contact hours for nurses. Nurses should claim only credit commensurate with the extent of their participation in the activity.

## Pharmacists & Pharmacy Technicians

Western Michigan University Homer Stryker M.D. School of Medicine designates this activity for 7.0 contact hours for pharmacists and pharmacy technicians. Pharmacists and pharmacy technicians should claim only credit commensurate with the extent of their participation in the activity.

## Social Workers

As a Jointly Accredited Organization, Western Michigan University Homer Stryker M.D. School of Medicine is approved to offer social work continuing education by the Association of Social Work Boards (ASWB) Approved Continuing Education (ACE) program. Organizations, not individual courses, are approved under this program. Regulatory boards are the final authority on courses accepted for continuing education credit. Social workers completing this course receive 7.0 general continuing education credits.

## Psychologists

This program is co-sponsored by the American Psychological Association for continuing education credit. The American Psychological Association retains responsibility for the program. This activity is designated for 7.0 APA CE Credits.

## Athletic Trainers

Western Michigan University Homer Stryker M.D. School of Medicine (BOC AP#: 4008183) is approved by the Board of Certification, Inc. to provide continuing education to Athletic Trainers (ATs). This program is eligible for a maximum of 7.0 (select one: Category A hours/CEUs. ATs should claim only those hours actually spent in the educational program

## Dietitians

Completion of this RD/DTR profession-specific or IPCE activity awards CPEUs (One IPCE credit=One CPEU). If the activity is dietetics-related but not targeted to RDs or DTRs, CPEUs may be claimed which are commensurate with participation in contact hours (One 60 minute hour = 1 CPEU). RDs and DTRs are to Select activity type 102 in their Activity Log. Sphere and Competency selection is at the learner's discretion.
